## President's Report (Karen McPhail)

<u>Strategic Planning Meeting</u>: This will be an update and expansion of our last Strategic Planning. Primarily, we will develop goals and action plans for each of the Board committees, so we will have specific plans for the next 3 years.

As part of our September meeting, we should begin planning for the AHA Faculty meeting which is due to be held summer 2008 in conjunction with an AHCB Board meeting.

<u>NARHA Conference</u>: Need discussion on how to publicize/promote our AHA workshop on Feldenkrais and Hippotherapy. Also, we have an annual meeting and need to award the Therapist and Horse of the Year Awards. On Sunday, at the end of the conference, Bonnie Cunningham is offering the first HPCS preparation course and we want to promote this also.

Discussion of merchandise for sale and the AHA membership table. We need to organize liaisons to help Linda. Anything to raffle?

<u>NARHA Certification Oversight Committee</u>: Currently, AHA has a position on this committee which reviews all the various types of NARHA certification and one of the committee's projects concerns the NARHA Registered therapist status.

<u>Website Management</u>: Consider hiring a website manager that would help Linda with keeping the material up to date and make our website more user friendly. The board is entertaining proposals for a new webmaster. Current contract will not be renewed.

### President

# **Executive Director**

# **Education Committee (Sarah Pictor)**

#### COURSE WORK:

Level I and Level II courses continue to be offered on the East and West Coasts. E-bulletin recently put out a statement for clarification to members that the Level II Equine skills can not be waived. There was a situation at one of the workshops in July where 2 therapists waived the equine portion.

Joann Benjamin has completed a review of Level I Manuals (ES and TP) and has updated the materials. (Thank you, Joann!!) Linda has the "master" along with a CD that Joann uses for power point to add to her teaching experience. This may not be appropriate for all Host centers, since technology for power point may not be available.

Level III Equine Skills is completed and ready to go!! First offering was to be at NCEFT this Sept., however, there was only one therapist registered, so this offering will be cancelled. Need to market/advertise this and push it at National in California.

Level III Treatment Principles continues to be discussed. There may be the opportunity to have several "layers" of this course with diagnosis specific interventions.

#### **FACULTY MEETING:**

Need to discuss further. The schedule dictates a meeting in July, 2008. I would like the meeting be scheduled for July—July 18-20, 2008 possibly in Chicago since it is in a central location and has direct flights from so many cities. Other venues discussed.

#### TERMINOLOGY:

Due to a reprint in STRIDES of an article published by John Sterba, there has been much discussion within NARHA, EFMHA and AHA regarding the necessity for consistent, accurate use of terminology across all disciplines. A task force was pulled together with a rep from the instructors, (Kitty Stalsburg) EFMHA (Ann Alden), NARHA (Jacqueline Tiley), Health and Ed (Steve McKenzie), and AHA (Sarah Pictor). Marsha Temple, new interim Executive Director for NARHA is cc'd on all email correspondence. The mission of this group is to develop an article that will be from all these perspectives to clarify the importance of using correct terms. Liability, scope of practice etc. It is hoped that it will be a multi-part series in consecutive STRIDES issues.

## AHA AND TAMU:

A multi-part online Continuing Education course is being offered this fall through Texas A&M University. The 4 tracks are Horse Care and Management, Therapeutic Riding, Mental Health, and Hippotherapy. The Hippotherapy portion is being developed by Sarah Pictor and Karen McPhail and will utilize the majority of material from Sarah's D'Youville Hippotherapy Course. Will request copyright privileges from NCEFT.

#### HIPPOTHERAPY TEXT:

As a result of such a successful conference in Atlanta, Jan Spink approached me about rewriting the **Developmental Riding Therapy** text and create a comprehensive Hippotherapy text book that could be marketable and used in AHA teaching. Jan's book has lots of excellent material and this would give AHA an opportunity to have a published text! We'll need contributors, proofreaders and discipline experts. I'll keep you posted with progress! ©
